### Merchandise Vendor Application

Spaces are available for rent in four sizes: 10' x 10', 10' x 20', 10' x 30' or 10' x 40'. Space can be reserved for either Saturday, Sunday or both days (*see below*). To reserve your space, payment **must** be sent with application and is non-refundable. In the application, **you must provide your Washington State tax I.D. number** in order to qualify as a registered vendor for our event. Cut-off date for receiving applications is **August 31, 2014**.

Vendors will provide their own booth(s) or table(s) in their area, and there will be **no electrical outlets** available for display purposes. Set-up must be done prior to 9 a.m. on Saturday and/or 10 a.m. on Sunday. **Take-down should not occur until after 6 p.m. on Saturday and/or 5 p.m. on Sunday.** There is no charge to vendors for overnight camping. **Directions to Tam O'Shanter Park:** Take I-5 Exit 39 onto Allen Street. Go east to Kelso Drive (at the first light to the east of the freeway). Turn right onto Kelso Drive, going south just past the Red Lion Inn. Turn left at the sign directing to the park, going east approximately 1½ blocks.
