Councilmember McAllister commented that there was a call for a vote with no motion made regarding the contract amendment for the South Kelso Grade Separation Design Services agreement with HDR, Inc. Motion passed, all voting yes.

PUBLIC HEARING:

<u>Six-Year Transportation Improvement Program (2020-2025):</u> Mayor Malone opened the public hearing at 6:08 PM. Community Development Director/City Engineer Mike Kardas provided an overview of the six-year plan for the improvement of arterial streets. Discussion followed.

There being no comment from the public, Mayor Malone closed the public hearing at 6:14 PM.

Upon motion by Councilmember Hill, seconded by Councilmember Lefebvre, 'Approve the agreement with Waste Control,' motion passed, all voting yes.

City Manager Transition Subcommittee Update: Councilmember Futcher commented that 18 applications were received by the deadline date. He commented that, from the pool of the 18, the consensus of the subcommittee was that there were 5 to 6 qualified applicants that they would consider as finalists. He asked for guidance from the Council to either use this pool of applicants or employ a recruitment firm to expand the pool. Discussion followed. The consensus of the Council was to have the subcommittee move forward with the current pool of applications. The subcommittee would determine the finalists from the 18 applicants then they would begin the background check process.
