The Deputy Clerk was directed to confirm and document the vote and bring the minutes back to the next meeting for approval.

#### **COUNCIL BUSINESS:**

West Main Re-alignment Phase 2 Project Construction Contract: Community Development Director/City Engineer Mike Kardas briefed the Council on the contract. Upon motion by Councilmember Harvey, seconded by Councilmember Lefebvre, 'Award the contract to Midway Underground of Toledo for \$4,509,097.52.' Councilmember Karnofski confirmed that if anyone was interested in obtaining an item from the construction site, they could get Midway Underground's contact information from the Engineering Dept. Motion passed, all voting yes.

**2021 Lodging Tax Request:** City Manager Andrew Hamilton presented the 2021 request. Upon motion by Councilmember Karnofski, seconded by Councilmember Lefebvre, 'Approve the request as presented'. Discussion followed. Councilmember McAllister, Karnofski, Lefebvre, Futcher, Harvey, and Malone voted yes. Councilmember Alexander voted no. Motion passed, 6 to 1.

Discussion followed. Motion passed, all voting yes.

Ordinance No. (1st Reading) Amending Garbage Service Rates: The Deputy Clerk read the proposed ordinance by title only. Upon motion by Councilmember Futcher, seconded by Councilmember Karnofski, 'Pass on 1st reading, 'ORDINANCE OF THE CITY OF KELSO AMENDING THE RATES TO BE CHARGED BY THE CITY OF KELSO FOR FURNISHING GARBAGE SERVICES EFFECTIVE JANUARY 1, 2021.' Discussion followed. Councilmembers Karnofski and Futcher voted yes. Councilmember McAllister, Lefebvre, Harvey, Alexander, and Malone voted no. Motion failed, 2 to 5.

Resolution No. 20-1239 – Joint Cooperation and Interlocal Agreement for the Construction of the South Kelso Railroad Crossing Project: The Deputy Clerk read the proposed resolution by title only. Upon motion by Councilmember Alexander, seconded by Councilmember Harvey, 'Pass Resolution No. 20-1239, 'A JOINT RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF COWLITZ COUNTY AND THE CITY COUNCIL OF THE CITY OF KELSO IN SUPPORT OF THE JOINT COOPERATION AND AN INTERLOCAL AGREEMENT FOR THE CONSTRUCTION OF THE SOUTH KELSO RAILROAD CROSSING PROJECT TO BE CONSTRUCTED ON PROPERTY WITHIN THE JURISDICTIONS OF BOTH THE COUNTY AND THE CITY.' Motion passed, all voting yes.
