<u>Façade Agreement:</u> City Attorney Brachvogel explained that the intent of the Promissory Note and the Deed of Trust with Mike and Dawn Julian was to have it replicate the HUD program which is currently in place. The interest rate will probably be set below prime. The only change is the requirement to refinance the property in the event of a sale or transfer has been stricken. Discussion followed.

Mike Julian, owner of Kelso Theatre Pub, spoke concerning the prospective changes in the contract.

Further discussion followed. City Attorney Brachvogel suggested changing the wording of the contract so that the loan couldn't be refinanced without discussing the intent with the City. Discussion followed.

Consider Kelso Housing Authority Request for Document Recording Fee Fund: Upon Motion by Councilmember Futcher and seconded by Councilmember Wheeler, 'Authorize the City Manager to enter into an agreement with the Kelso Housing Authority for use of the City's 2007 Document Recording Fees in the amount of \$16,200.00 for replacement of the elevator at the Columbia Apartments. The cost estimate provided by the elevator company is \$124,338. The County will provide up to \$100,000.00 from their Document Recording Fees. Discussion followed. Motion carried, all voting yes.

<u>Consideration of Offer for South River Road Property:</u> City Manager Robinson provided a map of the property which is approximately 8.5 acres and gave additional information about the potential sale. The City has received a full-price offer from BLC Investments, LLC, in the amount of \$1,100,000.00 to build a multi-family residential development including 240 units.

<u>Todd Nicholson, Nicholson Enterprises N. W., LLC</u>, spoke from the audience in favor of the project which will be good for the community, the golf course, and the City of Kelso.
