Upon motion by Councilmember McDaniel, seconded by Councilmember Schimmel, 'Pass on 1st Reading, 'AN ORDINANCE OF THE CITY OF KELSO REGULATING THE DUMPING OF REFUSE, JUNK, RUBBISH AND GARBAGE AT KELSO RECYCLING DROP SITES; AMENDING KMC 8.04.010 BY ADDING NEW DEFINITIONS; AND ADDING A NEW SECTION ENTITLED "UNLAWFUL ACTS", TO BE CODIFIED AS KMC 8.04.075.' Public Works Director David Sypher spoke about some of the amendments to the existing ordinance which will provide new definitions and clarifications of "unlawful acts" concerning garbage.
