Kelso Dancing Rules and Entry Information

1. Dance competitions will run under the rules of SDUSA & RSOBHD.
2. **ScotDance USA** reserves the right to return to more stringent guidelines should COVID numbers warrant. We will continue to monitor conditions and revise guidelines as necessary.
3. All attendees must comply with local & state covid guidelines. No refunds given.
4. Start times & Schedule will be available online.
5. Any dancer causing a delay will forfeit his/her entry in event. It is dancer's responsibility to follow platform schedule. First to enter, last to dance.
6. \$2 from each entry goes towards SDUSA NW Region.
8. All groups will receive medals except adult premier class who will receive cash awards. An aggregate trophy will be awarded in each class except Primary.
9. **The Aronson Memorial Perpetual Trophy** will be awarded to the Premier dancer of the day. If any Premier group drops below 6 dancers a dance off of all premier trophy winners will be initiated. Sean Triubhas 3&1 to be danced.
10. Age groups will be split according to entries.
11. Age is determined as of day before competition.
12. All judges' decisions are final. A \$40 protest fee must accompany any formal written protests.
13. **Solo Choreography -Premier Dancers only**
 - * Supply own music-iPhone/CD - 3-min max.
 - * **Must have Celtic theme and use Highland/National movements.**

4. Competitor numbers will be picked up on day of competition. Dancers must show current registration card.
