Stormwater Advisory Committee Meeting

December 10, 2008

Call to Order:

Steffanie Taylor called the meeting to order at 4:09 pm, at City of Kelso City Hall Conference Room 203, 203 S. Pacific Ave.

Approval of Minutes:

Gary Fredricks made the motion to approve the minutes of November 19, 2008, Tim Wines seconded. Motion carried, all in favor.

New Business:

- 1. Stormwater Permittee Position
 - The stormwater permittee member position was left vacant after former member Brad Bender voluntarily resigned. Van McKay received an application by Bo Storedahl who is interested in the industrial permittee member position. Bo Storedahl is currently employed with J.L. Storedahl and has previous experience as a water technician and is very familiar with industrial and stormwater pollution prevention/maintenance.
 - <u>Motion:</u> A motion was made by Tim Wines and seconded by Gloria Nichols to accept Bo Storedahl's appointment as a Kelso Stormwater Advisory Committee Member. Motion carried, all in favor. (The City Manager will need to make the formal appointment)
 - James Amaral sent Van McKay a resignation letter by email regarding the youth member position. Van McKay has contacted the Kelso High School Principal who referred him to the Career Counselor with whom he is waiting for a response. Gary Fredricks recommended inviting

interested students/youths to the next meeting as guests to get them involved as soon as possible in the already advanced process.
